DO HEREBY RESOLVE:
DECIDE, PAR LES PRÉSENTES:

- WHEREAS:** Chief & Council have determined that large amounts of alcohol and other intoxicating substances are being brought into the Reserve for unlawful purposes such as bootlegging and the providing of alcoholic products to minors;
- AND WHEREAS:** Chief & Council have determined that the social consequences of the providing of alcoholic products have a devastating effect on both the youth and the entire community as whole;
- AND WHEREAS:** the Council of Mathias Colomb Cree Nation is desirous of declaring in effect a limitation on the amount of liquor any one person can import onto the Reserve;
- AND WHEREAS:** the Council of Mathias Colomb Cree Nation is desirous of in place provisions enabling the searching of luggage, baggage, parcels, boxes or other containers entering onto reserve land, for the purpose of enforcing a limitation on the amount of alcohol any one person can import onto the Reserve. The person has to be there to claim the liquor being shipped to her or him within the liquor by-law;
- AND WHEREAS:** Subsection 85.1 of the Indian Act authorizes the Council of Band to make a By-law relating to the liquor on a Reserve;
- AND WHEREAS:** Subsection 103 (1) of the Indian Act authorizes a Peace Officer, a superintendent or person, authorized by the Minister, who believes on reasonable grounds that an offence against Section 85.1 has been committed, to seize all goods and chattels by means of or in relation to which he believes on reasonable grounds the offence was committed;
- AND WHEREAS:** a majority of the electors of the Band who elected Chief & Council of Mathias Colomb-Cree Nation Band on October 2, 1998, for the purpose of considering what is best for the Band including the establishment of by-laws, such as this by-law.

RESOLVE: that pursuant to the Council's effort to maintain peace, law and order and surveillance on bootleggers. Here are the acceptable limits a person can bring into Reserve. Either:

- 2 x 24 case beer with one 40 oz. whiskey.
- 3 x 24 case beer with one 26 oz. whiskey.
- 2 x 40 ounce spirits.
- 6 x 12 ounce spirits.

Can be bought into the Reserve for local consumption.

FURTHER RESOLVE: that the RCMP and Constables continue to search all vehicles entering the Reserve, and if one exceeds the allotted amount, all alcohol will be seized and destroyed.
